## Awarded the Highest Rating from the CDP in Two Environmental Fields Inclusion in Climate Change A List 2020 & Water Security A List 2020

Nabtesco Corporation (headquarters: Tokyo, President & CEO: Katsuhiro Teramoto) hereby announces that it was selected for inclusion in the Climate Change A List and the Water Security A List by international non-governmental organization CDP, being recognized as a company that is implementing outstanding initiatives and strategies against global environmental issues. Nabtesco has been included in the Climate Change A List for five straight years and is included in the Water Security A List for the second time.

Representing 515 institutional investors around the world who manage assets totaling 106 trillion US dollars, CDP collects and evaluates information about the environmental measures implemented by companies. In 2020, more than 9,600 companies, which collectively account for over 50% of global market capitalization, publicly disclosed their environment-related information through CDP.

Nabtesco set its long-term CO<sub>2</sub> emissions reduction targets for 2030 and 2050 in December 2016, and these targets are approved to be consistent with the 2 degrees Celsius target<sup>\*1</sup> set in the Paris Agreement<sup>\*2</sup> by the Science Based Targets initiative (SBTi)<sup>\*3</sup>. Nabtesco has been implementing thorough energy-saving initiatives on a global scale and making a concerted effort to reduce its CO<sub>2</sub> emissions, including introducing/updating highly efficient equipment and constructing/rebuilding factories by employing cutting-edge environmental technologies.

Moreover, for the conservation of water resources, Nabtesco has been doing the following: performing multiple water-related risk assessments on itself and across its supply chain in Japan and abroad; setting quantitative and qualitative targets for water-related activities; controlling the amount of water used and discharged; and ensuring the management of wastewater quality.

Nabtesco will strive to conduct a range of activities to solve various environmental and social issues toward the creation of a sustainable society.

- \*1 The 2 degrees Celsius target is an international target set in the Paris Agreement to keep the average rise in global temperature to below 2 degrees Celsius above pre-industrial levels.
- \*2 The Paris Agreement is a multilateral international agreement to curb climate change in and after 2020 and was adopted on December 12, 2015 at the 21st Conference of the Parties to the United Nations Framework Convention on Climate Change (COP21).
- \*3 The SBTs are intended to urge companies to set their medium- to long-term targets (for the period from five to 15 years from now) in a manner that allows the international community to achieve the 2 degrees Celsius target.
