As the 2023 deadline for execution of the options was approaching, we began to consider whether or not it would be an effective use of our assets to execute that right, and as a result, we decided to sell the shares of HDS in our possession.
3	Dissolution of the Cooperative Relationship	When you formed the cooperative relationship, in which field did you plan to generate synergy?	We worked to generate synergy by combining the technologies of the two companies to create new applications for precision reduction gears, which represent an integral component of devices in which motors are used. However, we were unable to make specific achievements.
4	Dissolution of the Cooperative Relationship	Will dissolution of the joint venture in the US have an impact on your business?	It will not have a major impact on our business, as we have few direct transactions with HDS.
5	Business Environment	You have referred to OVALO's technology for small products. Is it because the subsidiary has made a technological breakthrough?	As for small strain wave gears, we obtained the basic technology when acquiring OVALO and have already utilized it in the precision reduction gear business targeting automobiles and robots. As for further use of the technology, we would like to make decisions based on the needs of the market and our customers.
6	Sales of Shares	Did you decide to sell a portion of the shares of HDS in your possession for the purpose of increasing HDS's floating shares?	The proportion of floating shares to outstanding shares of HDS had nothing to do with our decision to sell the shares.
7	Sales of Shares	Did you decide to sell the shares because of the high stock price? Will you sell the remaining shares soon?	We didn't decide to sell the shares because of the high stock price. We discussed many times with HDS about selling the shares, and the decision was not made quickly. We plan to sell the remaining shares in a manner that will minimize the impact on the stock market.
8	Sales of Shares	Will the shares be sold at 8,000 yen?	The sales price has not yet been determined. It will be decided on the day when the sales agreement is concluded.
