### **Reorganization, New Management Structure and Changes in Officers**

Nabtesco Corporation (hereinafter, "Nabtesco") hereby announces that it has passed a resolution on its reorganization, new management structure and changes in officers as of January 1, 2019 at its Board of Directors' meeting held today.

#### I. Reorganization

#### 1. Details

- (1) We will establish a managerial position and organization for the supervision of the Precision Equipment Company (engaged in the precision reduction gear business) and Power Control Company (engaged in the hydraulic equipment business) in the Component Solutions Segment.
- (2) We will abolish the Advanced Mobility System Division of the Technology & R&D Division.
- 2. Reason for the reorganization
  - (1) Based on the current in-house company system, we need to establish a new managerial position and organization to generate more synergies in a cross-organizational manner.
  - (2) The Division will be dissolved to speed up the generation of synergies between Nabtesco, OVALO and adcos toward the future.
